### Terms and Conditions of *Powerline Components®* Remanufactured Products

- All pricing is FOB our facilities in Afton, Wyoming with the core return being at the customers expense.
- A rebuildable core assembly must be turned in at the time of the purchase, otherwise the customer will be charged with the listed core charge.
- All remanufactured products must be exchanged on a like for like basis.
- Core credit will be issued for rebuildable cores if returned within 60 days.
- All cores are due within 60 days of the date of sale.
- If the core is determined to be non-rebuildable, the listed core charge will be charged as an additional billing.
- All additional billings will be charged out within 60 days after receipt of cores.
- Unacceptable cores will be held for 30 days following notification of additional billings for customer inspection. After the 30-day period all unacceptable cores will be scrapped.

### **Remanufactured Products Warranty**

All remanufactured products are covered for a period of one year. This warranty covers replacement on malfunctioning remanufactured products occurring during the warranty period resulting from defects in material or workmanship. To obtain warranty replacement, the defective or malfunctioning product must be delivered to P C Industries (PCI) with a copy of the original invoice or repair order to validate the date of purchase. PCI may at its discretion, replace rather than repair the remanufactured product. A reasonable time must be allowed to perform the warranty repair after returning the remanufactured product to PCI. The warranty period begins on the date of sale.

This warranty does not cover replacement due to accidents, misuse, storage damage, negligence, misapplication or modifications exceeding the manufacturer's specifications. Labor costs for product removal and reinstallation are not covered by this warranty. This warranty does not cover any economic loss, including without limitation, communication expenses, meals, lodging, loss of use of the engine or equipment, loss of time, inconvenience, cargo damage or any other costs or expenses resulting from a defect covered by this warranty.
